Minutes of the Planning Committee meeting held in the Lower Hall, Ditchling Village Hall, Lewes Road, on Monday 20 January 2020 at 6.30pm

Neighbours of 7 Fieldway, Ditchling spoke about the negative impact the application SDNP/19/05385/HOUS would have on their property way of privacy and light issues. The plans showed a bedroom window overlooking their living accommodation and outside space. No consultation had been made with them by the developer and they had suggested that the roof could be altered to a hipped roof to mitigate the negative effects on their property.

A representative of the Ditchling Village Society commented on the current position with the Rugby Club and that the Council should ask the Planning Authority for an update on this site as they believed permission to use the site had expired.

	4.2 SDNP/19/05385/HOUS Erection of a two storey side extension - 7 Fieldway Ditchling Hassocks East Sussex BN6 8UA — The Council object to the application on the grounds that the plans do not show adequate information on how they affect adjoining properties and that consideration should be made regarding privacy and loss of light issues to adjoining properties.
